5) County Librarian Update.

- a) New Finance Business Manager. Carina Gil.
- Carina gave a background of her career with Fresno County after graduation from Fresno State.
- Laurel explained that Carina is taking on a huge task of creating cost centers for each branch. This will be a big task in our budget. This has been in the planning for six months. It will occur at the start of the next fiscal year in July.
- b) Library Foundation Fundraising Initiatives
- The Foundation has now funded two Early Learning Centers. West Fresno and Fig Garden. Their commitment was to fund five so they are still working on this initiative.
- A gala is planned for June as the Foundations inaugural fundraisers
- c) Facilities
- Sierra Vista Mall Branch. The kiosk will go live mid March.
- H/Q Library Administration. We are hoping to purchase Channel 47 studio on 1st St. and Shaw Ave.
- Clovis Branch talks are underway with City officials and obtaining a site is only a few months away (pending Board of Supervisor approval),
- Reedley Branch is still looking for real estate options.
- Teague Library (New Branch). Our second joint-use facility with Central Unified is Teague Elementary. The expected date of opening is June 1st.

d) Program Success

- LSTA funded LEAP (Learn, Engage, Achieve, Play) Program will commence at Sunnyside Branch March 1st. This program is designed to assist parents who have children with special needs such as autism.
- The Big Read-The Great Gatsby kicks off March 5th. Many exciting programs are planned and it is guaranteed to be a success.
- Early Learning Center at West Fresno is slated for opening National Library Week in April.
